The goal of an infection prevention and control program is to prevent health-care associated infections among patients, and injuries and illnesses in healthcare personnel. This presentation will discuss strategies for ensuring compliance with relevant Centers for Disease Control and Prevention (CDC) guidelines, Occupational Safety and Health Administration (OSHA) regulations and other relevant recommendations, regulation and standards. The CDC Summary of the Infection Prevention Practices in Dental Settings-Basic Expectations for Safe Care will be used to demonstrate how to monitor and evaluate a site-specific infection prevention and safety program. Companion resources from the Organization for Safety, Asepsis and Prevention (OSAP), will also be shared with participants.
